**AN ORDINANCE AMENDING SCHEDULE "B"  
OF THE PROVISIONS OF ORDINANCE NO. 681-99 AS AMENDED BY  
ORDINANCE 1100-66  
TO AMEND THE LENGTH OF SERVICE  
AWARD PROGRAM OF THE BOROUGH OF OLD TAPPAN**

BE IT ORDAINED by the Mayor and Council of the Borough of Old Tappan as follows:

**\*Extra Hours include all activities that benefit the Corps except monthly business meetings, drills, and times spent on call. Some examples of extra hours activities are rig checks, committee meetings, cleaning, CEU classes, audits, ordering supplies, events, record keeping, training, on call events for second rig. It is the responsibility of each member to make sure extra hours are recorded on team pages.**

**Section 2. Repealer**

All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflicts.

**Section 3. Severability**

If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Borough of Old Tappan declares that it would have passed the ordinance and each section and subsection thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

**Section 4. Effective Date**

This ordinance shall take effect upon passage and publication according to law.
