Discussion on noise from gas leaf blowers will continue at EC meeting on May 16 as the subject has been sent back to EC by the Mayor and Council. Councilman Gallagher stated that the issue is whether or not contractors and landscapers should be in the same category as they are right now as things have changed throughout the years. David Keil commented that the ideal fix would be if the manufacturers could quiet the leaf blowers. This issue began when a resident complained about the noise from leaf blowers and who started a petition. This resident is invited to attend EC meeting on Tuesday so she can hear first hand what the discussions are.

Councilman Gallagher reported that the municipal budget has passed. The Mayor and Council continue to pay attention to Affordable Housing and will do so over the next several years. Discussion ensued on how placement of Affordable Housing would affect resources; especially schools.
