Chair Weidmann asked if the budget meetings are open to the public. Councilman Boyce stated they are closed right now while they meet with the Department Heads. CONSTRUCTION OFFICIAL REPORT

Approval of January 8, 2020 Regular Meeting Motion to adopt – Mr. Alessi

One voice vote all in favor, none opposed, the minutes are approved with the exception of Mr. Eller who was not present at the last meeting; he abstains from voting.

NEW BUSINESS

Appeal Denial: Dr. Eric Trenkman @ 18 Corrigan Way Mr. Neil Christensen, Contractor for Above

Both gentlemen are present and sworn in by Mr. Regan. Dr. Trenkman starts testimony by stating that he was trying to build a modified basketball court in the back yard.

Chair Weidmann asks if any work has been started on it yet to which Dr. Trenkman responds, yes. Mr. Christensen takes over the testimony. He states that the Engineer was on site, there was a dispute with the neighbor as to the property lines so he had a Site Plan drawn up and a survey done. Everything was submitted to the Borough.

The court, as it is designed right now, is 16' off of the back property line and 10' off of the west property line. Mr. Christensen thought, as a structure, it would be approved. It falls under no lot coverage issues, drainage is done and everything is on the plan.

Mr. Regan asks if the applicant knows what the impervious coverage would be with the basketball court. Mr. Christensen states that was all submitted to the town and that it all falls underneath the code. The project was failed because of a Use Issue not a structure issue. There is nothing in the Old Tappan code that references a basketball court so it was deferred to a tennis court and those setbacks are to be 30' from *all* property lines.

Mr. Regan states, "... well if you look at 255-13B4 it permits the following accessory uses permitted: swimming pools, tennis courts and similar recreational facilities subject to the provisions of 218, chapter 255. Why wouldn't this be governed by that provision? Clearly a basketball court is not similar to a pool so the Construction Official deemed it to be similar to a tennis court."

Mr Christensen stated that his conversation with Zoning Officer was that the use of the word "court" defined the activity.

Mr. Regan states "if you don't believe that provision governs then I think you need a variance to sanction a basketball court because it is not an accessory use. You are either governed by this section "similar rec facility" or the alternative is that it is not a permitted use and then you would seek a variance – to permit an accessory use that is not included in the zoning world."

Mr. Christensen states that he thinks 30' is excessive for most properties in Old Tappan. And in his opinion, he feels the Ordinance needs to be updated.

Mr. Regan thinks, in his opinion, that the homeowner will need a variance because the location of the basketball court is less than 30' from the rear side property.

Mr. Regan refers to 255-93B which states, "no court, it doesn't say tennis court or basketball court, it states NO COURT shall be located within 30' of all lot lines."

A resident from 22 Corrigan Way would like to speak . . . she refers back to the issue with the property lines and states that a bunch of large trees were removed . . .

Mr. Regan states that is not something that would come before the Board and that she should reach out to a Land Use and/or a Real Estate Attorney regarding her issue. As of right now they cannot construct the court beyond the 30' setbacks.

Application fee for a d(4) FAR variance – Section 45-23

In a discussion with Mr. Regan with regards to an application fee for an incoming application, it was determined that there is no fee for a d(4) FAR Variance pursuant to Section 45-23. Mr. Regan and the Board Secretary decided together that the \$ 200.00 application fee was acceptable but that this oversight needs to be corrected. A memo should come from the Board to the Mayor & Council asking for a FAR variance application fee to be added to 45-23G.

Chair Weidmann asks the Board Secretary to take care of that.
