Mr. Daniel Steinhagen starts his testimony at 9:47 p.m. He reminds everyone that this Resolution was adopted by this Board back in June 2019. The developer at that time fell through and a new developer will be in charge of this project. They have made some revisions to the exiting site plan.

The Architect, Mr. Alex Zepponi is sworn in for testimony. There will be a reduction in Building #3 and #4, the total building coverage will be lessened.

Previous plan: Maximum Coverage by Buildings was **23.3%**New plan: Maximum Coverage by Buildings will be **21.8%**

Previous plan: Maximum Improved Lot Coverage was **54.7%**New plan: Maximum Improved Lot Coverage will be **53.2%**

Previous plan: Minimum Front Yard Setback was **55**' New plan: Minimum Front Yard Setback will be **50**'

Previous plan: Maximum Length of Building was **216**'
New plan: Maximum Length of Building will be **208**'

The patios may be getting a little bit larger.

Mr. Steinhagen states that no conditions of the Resolution have been affected.

Questions from the Board:

Councilman Gallagher asked "why?" Mr. Zepponi states "because my client asked me to do it." Mr. Steinhagen states that it was a "business decision."

Some units are going from 4,200 sf to 3,646 sf and the interior units are going from 3,600 sf to 3,004 sf.
