Mr. Carl Calise, Homeowner and Ms. Stephanie Pantale, Architect are present to give testimony and are both sworn in as well as Mr. Szabo and Mr. Skrable.

The architect starts by giving some background to the property . . . It is located in the RA-15 Single Family residential district and is irregularly shaped. The application proposes an addition to the rear and side of the existing home for a kitchen/garage area. The property does have an existing nonconformity in the rear yard setback at 17.4 feet. With the proposed revisions, the rear yard setback would be 22.2 which is still not in compliance with the 35 foot requirement. The work proposed for the side of the home would decrease the existing nonconformance from 58.3 feet to 53.9 which is considered an improvement as the requirement is 10 feet.

Ms. Pantale continues that the total square footage increase will be 302 square feet – with 108 sf being for the garage and 194 sf being for the kitchen renovation. The FAR will increase from .0957 to .1097 and is caused by the unique shape of the property.

Neither Mr. Skrable, Borough Engineer, nor Mr. Szabo, Planner, have any concerns with the application as it is presented to the Board and feel that it would be an improvement to the existing dwelling as well as bringing it "up to date."
