#### **ENGINEER'S REPORT**

Borough Engineer Thomas Skrable reported as follows:

2017 Paving Program – finalized road paving list; close to budgeted amount of \$500,000; ready to begin work.

D & L Paving – contractor agreed to start work in the month of July and continue until completed.

#### **Telephone Poll Request – 47 Old Tappan Road**

Borough Engineer Skrable reported that the owner of 47 Old Tappan Road is requesting the installation of a new utility pole to run overhead lines from the opposite side of the street to the front of his house and then under ground for service. Dr. Brunquell, owner of 47 Old Tappan Road, testified that Orange & Rockland is requesting the pole. Borough Engineer Skrable commented that it was decided long ago that these requests come before the Mayor and Council. Councilman Nalbandian reported that the Borough has a new Pole Ordinance in place and asked how this request may be affected by the ordinance. In order to save time, the Mayor and Council decided to approve the request for placement of a pole contingent upon the Borough Attorney reviewing the current Pole Ordinance.
