Ordinance 1116-17 - Bamboo Ordinance - Resolution of Adoption

Steve Greenspan, a bamboo horticulturist, commented on the Bamboo Ordinance up for adoption this evening. He specializes in bamboo removal and felt that the ordinance in its current form will not solve the problems that occur from bamboo. He displayed 2 enlarged photographs and explained bamboo growth. Bamboo placed in a container or concrete can be cracked by the bamboo roots. He commented that the ordinance will not satisfy Old Tappan's goal.

Borough Attorney Allen Bell asked how Mr. Greenspan can assist the Council with their ordinance. Mr. Greenspan said that you need to eliminate "running" bamboo. Councilman Cioce stated that the ordinance can be brought back to the Environmental Commission for further review and input. Councilman Nalbandian motioned to table the ordinance with a second by Councilwoman Haverilla. Discussion ensued on timing to adopt the ordinance. Councilman Nalbandian rescinded his motion to table.

Dorothy Espen asked how you can tell what kind of bamboo it is. Mr. Greenspan replied that you cannot tell all the time.
