ENGINEER'S REPORT

Borough Engineer Thomas Skrable reported as follows:

Drainage Project – the DOT allowed the Borough to combine grants allowing us to use all the funds for the drainage project. Scheduling needs to be decided. We need to go out to bid by February 2020.

Stone Point Park – we are working on the drainage design for the back field. Need to decide final design concept.

COUNCILMAN CIOCE – ENVIRONMENTAL / LIBRARY / HISTORICAL

Councilman Cioce was contacted by a resident asking to become a member of a committee. She was provided board member availabilities and opportunities. He received an email from a resident requesting information on our tree ordinance specific to cutting trees. Our 125th Anniversary Event is coming along well. Scott and Gloria Wiesner have been doing a great job with planning.

COUNCILMAN YHU - SAFETY / SENIORS / AFFORDABLE HOUSING

The Safety Committee meeting is on September 18th; Councilman Yhu will attend. The Local Assistance Board met on June 24th; they along with the Senior Citizens Committee are hosting an International Lunch and Learn on October 10th. Meals on Wheels, along with help from the Girl Scouts, are working on holiday gift bags. The Senior Advisory Committee will meet on September 19th. In an effort to expand Old Tappan's Stigma Free Program Councilman Yhu organized a Mental Health First Aid training class which will be held on Saturday, October 12th. Affordable Housing – Councilman Yhu is continuing to speak with young emergency service volunteers to keep them apprised of affordable housing opportunities. September 10th is National Suicide Prevention Awareness Day.

Alumni in Recovery will have a walk on October 27th at Westvale Park in Westwood; Councilman Yhu plans to attend.

COUNCILMAN GALLAGHER – PLANNING / ARTS & ENTERTAINMENT / FIRST AID

The annual New Jersey State Fireman's Convention will be held in Wildwood, NJ on September 12 - 14. The Fire Department and Ambulance Corps will hold open houses and Safety Night on October 15^{th} . The EMS shared services agreement with River Vale is progressing. We will be provided with copies of proposed residency of a Fire Chief for discussion at the next meeting.
