ENGINEER'S REPORT

Borough Engineer Thomas Skrable reported that a vast majority of the field work at Stone Point Park is complete. There is still some work that needs be done to fields and the path paved.

Councilman Carnazza asked when the drainage work is supposed to be done.

Mr. Skrable said soon, that they need to come up with a schedule.

Mr. Skrable reports that DeWolf Road is close to getting started. Test holes are scheduled for tomorrow. D&L is not overly responsive right now.

Councilman Yhu asked if the Library had contacted Mr. Skrable about their roof and solar panels.

Mr. Skrable said they had not. Probably because they are closed for the time being.

COUNCIL COMMITTEE REPORTS AND REVIEW OF CORRESPONDENCE

COUNCILMAN BINAGHI - POLICE / AFFORDABLE HOUSING

The Police Department has received a directive from the Prosecutor's Office in regard to staffing. If there are any staffing problems due to the virus then the County will provide officers. Officers not on duty must stay home. Special Duty has been cancelled.

He received a Chief's contract from Joe Tracy on Wednesday. The Police Committee will review it and hope to appoint him on April 20^{th} . Captain Tracy is currently serving as the de facto Officer in Charge.

Mrs. Haverilla added that the Police Department is currently doing their own cleaning and the public is not allowed in the building.

COUNCILMAN BOYCE - GOLF / PLANNING BOARD / ENVIRONMENTAL

He is concerned about the Golf Course being closed. The Superintendent and his crew are still maintaining it. He inquired if the Mayor & Council were interested in giving the restaurant a break on the rent for April and May. He will speak to the CFO about this. Will do some research and discuss pros and cons at the April 20th meeting.

The Community Garden is open and allowing one person or family at a time. The Environmental Commission is considering doing a photo contest and the winner's photo will go in the time capsule. All were ok with this. They are going to try and do the next Environmental Commission meeting via Zoom.

The April Planning Board meeting was canceled.

COUNCILMAN CARNAZZA - RECREATION / HEALTH

The Recreation Commission & Board of Health are hoping to do their next meetings via Zoom. He will have reports on both after that.

Councilman Carnazza asked Mr. Bell if he has heard anything about the Recreation Commission lawsuit.

Mr. Bell has not heard anything but will make a follow up call.

COUNCILMAN NALBANDIAN - DPW / CONSTRUCTION

The DPW is taking protective measures with staffing. The staff is being staggered. One crew works 3 days in a row, they then clean everything before the next crew comes on for 3 days. They do not have any contact with the public.

Pump Station #2 grinder failed and a new pump has been ordered. The CFO found money in the budget for it. A temporary grinder is being uses in the meantime.

Mulch delivery has been suspended. Chipping will begin soon.

The Recycling Coordinator has been getting recycling from the former Pearson building project.

He explained that the Construction Official is currently in quarantine but will be done soon.

COUNCILMAN YHU – SCHOOLS / SENIORS

The schools remain closed. The kids are learning remotely. The regional board of education held their meeting via Zoom at which the budget was discussed. There is legislation out there to delay payments to the schools.

All Library & Senior events have been canceled.

He and Mrs. Haverilla delivered Meals on Wheels. The food pantry is well stocked.

He is trying to get the resident email blasts going. One was sent out but Councilman Gallagher reported that it looked fishy. Mrs. Haverilla will add it to the website.

COUNCILMAN GALLAGHER - FINANCE / FIRE / FIRST AID

The Fire Department and First Aid Corps are making protocol changes. A conference call was held today about it. The trucks are being disinfected. The First Aid Corps is still very responsive even with reduced staffing. He thanked Mrs. Haverilla for her efforts as OEM.

MAYOR'S COMMENTS

Recognized the entire Borough family for their continued support of Old Tappan. He especially thanked the emergency services. They are owed a deep debt of gratitude.
