Professional Service Contract – Borough Attorney

Mayor Kramer commented on the appointment of Brian Giblin to replace Allen Bell who will be retiring after serving our community so well for the past twenty years. The position was advertised; applications were filed with the Borough Administrator. The search committee consisted of Councilman Gallagher, Councilman Yhu and Mayor Kramer. Interviews were conducted with the top six candidates that were selected. It was unanimously agreed that Brian Giblin Sr. was the most qualified to fit the needs of Old Tappan. Mayor Kramer provided background and qualifications of Mr. Giblin.

Councilman Gallagher stated that the committee met with applicants and the recommendation is to hire Brian Giblin as Borough Attorney.

COUNCIL COMMITTEE REPORTS

COUNCILMAN CARNAZZA - RECREATION / HEALTH

The Recreation Commission held their meeting. Camp and all summer activities are cancelled. We are talking about Town Day and the fireworks display in September. Board of Health – the Health Officer Angela Musella has submitted her resignation and will be retiring; we have a meeting on Wednesday and I will know then who her replacement will be.

COUNCILMAN YHU - SCHOOLS / SENIORS

Schools – spring events and the prom have been cancelled. An event may be planned for August. Graduation will be digitally videoed in front of the school; all students will receive a copy of the video. Under Consent Agenda this evening we approved the Shared Services Agreement – 2020 Road Paving – NVOT School District. Senior events have been postponed until deemed safe to continue with them. As a message to our residents regarding tax payments, the Borough is here for you, we have a number of resources if you are in need.

COUNCILMAN BINAGHI – POLICE / AFFORDABLE HOUSING

The Police Committee has been very busy. I received a call from a long-time resident who owns a printing company in Norwood, Control Pharmaceuticals. He is making and donating face shields to first responders. Councilman Binaghi provided him with the name and contact number of our First

Aid Captain and Police Chief. The Police Committee interviewed candidates for Police Lieutenant, which will be discussed later this evening. We will be hiring two patrolmen one for now, two are desired; we have good candidates. Councilman Binaghi recommended hiring two, staggering the hires one meeting apart.

COUNCILMAN BOYCE - GOLF / PLANNING BOARD / ENVIRONMENTAL

The Golf Course has been open since April 2^{nd} in a two-some format. Beginning Friday, four-some play will be allowed using social distancing. The new "cozy corner" is open for couples only. The restaurant is open for takeout orders. The downstairs bathrooms are open. The Environmental Commission will hold a zoom meeting tomorrow; the tree ordinance will be discussed. The Community Garden is planted. Planning Board -200 Old Tappan Road application has been approved with a small punch list. Boy and Girl Scouts patrol meetings are being held remotely.

COUNCILMAN NALBANDIAN - DPW / CONSTRUCTION

The DPW has a full force of employees and ended split shifts practicing all social distancing requirements. Mulch deliveries will resume in two weeks. Councilman Gallagher asked about the removal of clothing donation bins with no replacements. Councilman Nalbandian responded that due to the Coronavirus bins have been removed for now.

COUNCILMAN GALLAGHER - FINANCE / FIRE / FIRST AID

Councilman Gallagher commended our Borough Hall staff for everything they do for the Borough under these circumstances. He thanked the emergency services volunteers, First Aid Corps and Fire Department. Councilman Gallagher thanked Councilman Binaghi and Councilman Yhu for donating items. Last Monday the Fire Company held a zoom meeting and this week the First Aid Corps will hold a zoom meeting on Wednesday.

MAYOR'S COMMENTS

Memorial Day – there will be no parade or normal ceremony due to the circumstances of the Covid-19. We are planning a service at Oakes Park on Memorial Day at 9:00 a.m. which will not be open to

the public but will be recorded and played on various platforms. Mayor Kramer reviewed the plans for the morning and attendance.

Mayor Kramer read a statement acknowledging Borough Attorney Allen Bell's last meeting and retirement. He spoke highly of him and his professionalism, knowledge and twenty years of service to the Borough. On behalf of everyone, Mayor Kramer wished him well in his retirement.

Allen Bell stated that in his 49 ½ years of practice it has been an honor to represent the Borough of Old Tappan. It has been a rewarding and interesting experience. He has enjoyed working with everyone throughout his tenure. Old Tappan is an extremely well-run Borough that has a lot to be proud of. Thank you for the honor to represent Old Tappan.
