## COUNCILMAN YHU – SCHOOLS / SENIORS

The Board of Education continues with their hybrid learning. The Board President is up for reelection. Library – most patrons have been seniors. Seniors – line dancing is available at Stone Point Park. Community Development – the Fire Department and First Aid Corps are still planning on running a Halloween Drive-by – looking for candy donations. Social Services thanks Stokes Farm and the Community Garden for donations to the pantry.

## COUNCILMAN CARNAZZA – RECREATION / HEALTH

The Recreation Commission meets tomorrow evening. No report for the Board of Health until their next meeting.

## COUNCILMAN NALBANDIAN – DPW / CONSTRUCTION

DPW – the Superintendent would like to amend the Overnight Parking Ordinance to add to it no parking on snow covered streets overnight. The Borough Attorney recommended adding definition of the quantity of snow.

## COUNCILMAN BOYCE – GOLF / PLANNING BOARD / ENVIRONMENTAL

Golf Course – the Superintendent installed 22 tons of sand to the bunkers and another 22 tons to be added tomorrow. He plans on repairing lights with the balance in his budget. The Environmental Commission has plans to continue to discuss deer culling. There have been accidents and endangerment to plants. Hooked on Fishing will be held October 17<sup>th;</sup> looking for volunteers to assist. They discussed a possible new location on Chestnut Street for an additional Community Garden.

There is a Green Infrastructure Storm Water Management seminar available; Councilman Boyce suggests that both the DPW and Golf Course Superintendents attend. Planning Board meets October 14<sup>th</sup>. The Environmental Commission would like to see an electronic newsletter. The Borough Administrator reported that the last update was electronic.

The first Boy Scout meeting was held at the Old Tappan Firehouse.

## COUNCILMAN BINAGHI – POLICE / AFFORDABLE HOUSING

Police Chief reports that he anticipates an injured officer to be back on duty November  $1^{st}$ . Another officer will be out beginning October  $23^{rd}$  for approximately 4 - 6 months; the injury was not work related. The Police Chief held a department meeting last week.

Will move forward with a new CAD record system by mid-November. He is working on policies including vacation and promotional processes. The Police Chief will have new GPS systems installed in all police cars. He presented his recommendations for a policy on sick leave for Mayor and Council consideration which were discussed.
