## COUNCILMAN GALLAGHER - FINANCE/FIRE

## COUNCILMAN BINAGHI - POLICE/AFFORDABLE HOUSING

Read the monthly Police Department report and gave details.

Mayor Kramer inquired about an accident at the corner of Orangeburg Road and Old Tappan Road.

Councilman Gallagher answered that there was an accident.

## COUNCILMAN YHU – FIRST AID/SCHOOLS/SENIORS

The schools are still on hybrid and virtual learning. The local school board will be writing our legislators about having the teachers considered essential workers so they can be next up for vaccinations.

The Library is still closed but is open for curbside pick and drop off.

The CVS in Northvale and Dumont are offering the vaccine which he informed our senior citizens about.

He will address LOSAP at another meeting.

Alumni in Recovery would like to hold the Black Poster Project again in Oakes Park on June 5<sup>th</sup> with a rain date of June 6<sup>th</sup> provided it complies with the Governor's order for outdoor gatherings.

COUNCILMAN BOYCE - GOLF/PLANNING BOARD/ENVIRONMENTAL

The Golf Commission is creating a strategic succession plan for the next 3 - 5 years. Want to make sure the course is in the best physical shape with the best membership and revenues. There is a lot of momentum for the commission to figure this out. Just need to get things settled with the concessionaire and their rent. They received a quote for the expansion of the fence.

The Planning Board currently has no applications before it but one might be coming up for the March meeting.

The Environmental Commission it still looking to develop a concept plan for the walking trail and second community garden.

Mayor Kramer discussed some potential building renovations at the Golf Course.

Councilman Boyce would love for the Golf Course to become the community hub.

### COUNCILMAN CARNAZZA – RECREATION/HEALTH

The Recreation Commission will not be making any request to the schools for indoor sports. Trying to do as much as they can outside.

The Board of Health meets tomorrow night. Surrounding towns are looking to work together on vaccinations. He deferred to the Mayor on this topic.

Mayor Kramer explained that a Norwood councilwoman wants to put together a consortium of 9 towns for a vaccination site in the Northern Valley area. They will be making a presentation to our Board of Health tomorrow night. The Closter Mayor is also trying to get a vaccination program together as well. There will a zoom meeting on Thursday to discuss it.

Mrs. Haverilla spoke with FEMA today about using Old Tappan as a potential site. It is still in the early stages because plans need to be created and put in place. It is a big undertaking.

#### Tree Removal

The Mayor read an email he received from a resident of DeBerg Drive in regard to the removal of older, overgrown trees on his street due to the issues they are creating. He then read his response to the resident. He is thinking of asking the DPW Superintendent to make an assessment and meet with the resident. Councilman Boyce will join the DPW Superintendent.

Councilman Boyce feels that when we remove trees we need to inform the neighbors prior to the removal with an explanation as to why the removal is necessary. He is still getting complaints about the trees removed at Stone Point Park.

#### **DPW Mechanic Services - Norwood**

Councilman Boyce spoke with the DPW Superintendent who explained that we have been providing these services to Woodcliff Lake with much success. Norwood has a smaller fleet and feels that we could handle it. He mentioned possibly hiring a part time mechanic. Harrington Park has expressed interest as well.

Mrs. Haverilla explained that Norwood prepared an agreement and forwarded it to our Borough Attorney. We just need to adopt a resolution if all are ok with it.

The Mayor of Hartington Park contacted Mayor Kramer asking if we had room at the leaf dump and about wood chips. He spoke with the DPW Superintendent and we do not have room in the leaf dump. He can help them out with wood chips this summer.
