### **ENGINEER'S REPORT**

Mr. Skrable stated that there were 2 bid advertisements in the newspaper today for the NJDOT project on DeWolf Road and the Haring Drive footbridge replacement that is a FEMA grant. Both bids will be received on May 11<sup>th</sup> and awarded on May 15<sup>th</sup>.

Councilman Binaghi asked for the DeWolf Road project timeline.

Mr. Skrable answered that he stretched the completion date out knowing the he needed to coordinate with the Golf Course and Stokes Farm.

Mr. Skrable explained that they are working through some issues on Wescott Street. These issues are with the contractor and communication has broken down. Another issue is on Perry Street. It appears that the contractor crushed part of a pipe because there was flooding after the last storm. He is working through both of these issues.

The issues with the sub-contractor, along with payment and the history of the issues on Perry Street were discussed.

Mrs. Haverilla stated that there is a meeting with the Perry Street homeowners on May 16<sup>th</sup>. Hopefully these issues are resolved prior to this meeting.

### COUNCIL COMMITTEE REPORTS AND REVIEW OF CORRESPONDENCE

### COUNCILMAN BINAGHI – GRANTS/HISTORICAL

The Old Tappan signs will be getting fixed by a resident with help from the DPW. The resident will also be joining the Historical Committee. This Wednesday at 7:00pm there will be 2 speakers coming to the fire house for a seminar.

### COUNCILMAN GWON - RECREATION/LIBRARY/SCHOOLS

The 7<sup>th</sup> and 8<sup>th</sup> grade girls' soccer team was unable to attend tonight's meeting due to tryouts for another team. They will attend a future meeting to receive their proclamation. Since we received a grant for the pickle ball courts we are now able to do more than just the paving. We have at least 220 applicants and can now potentially run our own program. This will be discussed by the Recreation Commission. Installing permanent nets and fencing was discussed.

The Library Board goes through a rigorous process when it comes to bidding items and

long-term planning. He wants to see what their long-term capital projects are so a multiyear plan can be put together for budgeting purposes.

The high school has had a very successful college acceptance season. Spring sports will be starting.

### COUNCILMAN YHU – DPW/SENIORS/FIRST AID

The DPW is still accepting applications for a full-time laborer and part-time mechanic. We will be entering into more interlocal agreements for mechanic services. Discussed what the sewer bond ordinance introduced tonight will fund. Read the April 2023 activity report.

Read the First Aid Corp's April activity report.

The Seniors enjoyed last weeks dinner sponsored by Northern Valley Living Magazine. On Thursday they will be holding their annual meet and greet.

Councilman Gwon inquired about the work happening near the Chestnut Field parking lot.

# COUNCILMAN CARNAZZA – POLICE/ADMINISTRATION/HEALTH

The Police Committee interviewed 3 candidates for 2 patrol officer positions. We are hoping to appoint them at the next meeting.

Summer hours were discussed for the Borough Hall staff. The proposed hours would be 8:00am-4:00pm Monday - Thursday and 8:00am-1:00pm on Fridays and would run from Memorial Day through Labor Day.

Discussion ensued and all were in favor of the proposed summer hours.

### COUNCILMAN BOYCE - GOLF/PLANNING BOARD/FIRE

The golf course is continually being used and the membership numbers are up. They are still trying to determine if they need a dog to chase the geese away.

We have a new Eagle Scout and the ceremony was held on April 22<sup>nd</sup>.

The Environmental Commission has a nice piece of wood to make into a sign for the new community garden. This will help the boy scouts with their woodworking merit badge. He will be doing a drawing to split the garden into 20 plots.

Met with the Borough Attorney last week to review the proposed tree ordinance.

Thanked everyone involved with the budget process.

**MAYOR'S COMMENTS** 

Attended the Safety Breakfast where we were given a platinum award and a check for \$1,750.00, the Pascack Valley Mayor's meeting where they discussed flooding issues, baseball and softball opening day and the Borough's Health Fair.

Travelled around town checking on flooding issues. He was happy to see that the United Way's project on Grace Avenue has begun.

Asked Councilmen Binaghi and Boyce to continue working on the Oakes House replacement project along with the DPW Superintendent and Borough Administrator.
