OLD BUSINESS

Golf Course Fence

Mayor Kramer explained that there is a Borough fence that is in disrepair on the golf course property at the end of Mavis Road. Our golf course management company has suggested that we continue the chain link fence from the gate south and connect with the fence that exists behind the maintenance building. A 6-foot-high black chain link fence is the suggestion. There is another suggestion, that provides no security at all, to replace the fence with a split rail wooden fence similar to what is currently there.

Councilman Boyce explained that the 6-foot fence continues as a 3-foot wooden fence followed by a 4-foot cyclone fence to the gate. There is roughly about 160 feet of the 3-foot split rail fence.

Mrs. Haverilla explained that the other option is to have from the gate a 4-foot black chain link fence going to the 6-foot chain link fence so that it is all uniform and closed.

Councilman Binaghi stated that at the last meeting we left it that Councilman Carnazza was going to speak to the Sheridan's. What was the outcome?

Councilman Carnazza spoke to Mr. Sheridan and explained what happened at the last meeting and that we are waiting on Councilman Boyce to be present before we make any decisions. He is going to report back to the Sheridan's on our decision tonight. Mr. Sheridan has offered to pay for the wooden fence. He then explained the 2 options that are on the table for tonight.

Councilman Boyce explained that the golf course management company would like to fence in the whole golf course with a 6-foot fence. At least ³/₄ of the course is already fenced in. Another fence option, if the Sheridan's are willing to pay for it, is to use black locust posts, with rails and then staple a wire mesh to it.

Councilman Gwon explained that if we leave the fence status quo we are not catering to any one person. We are not setting a precedent.

Discussion ensued on the different types of fencing, the height and location, the benefits of the fencing and the future plans for continuing the fencing around the entire golf course.

Councilman Boyce made a motion to obtain bids for a locust fence to replace the current wooden split rail fence, use a 6-foot cyclone fence behind the maintenance building along with a 6-foot gate.

COUNCILMAN BINAGHI - GRANTS/HISTORICAL

The Historical Committee has a nice display for Town Day.

He has received additional information on the Oakes Park Building. Green Acres is being strict on what can occur at the house so we will have to modify the proposed event space.

Councilman Boyce suggested adding giant garage doors on the outside of the building so we make it fully open. We can ask Green Acres if this is allowable.

Mrs. Haverilla explained that this issue with the Oakes Park House came about because Green Acres just did an impromptu inspection of all of the town's Green Acres properties. She described their findings one of which was that the Oakes Park House is in disrepair and wanted to know what is being done. She sent them the proposed renderings and they came back with that the percentage of event space shown is over the requirements.

Councilman Binaghi asked who needs to be involved in the bid process for this project.

Mrs. Haverilla answered that the Borough Engineer and Borough Attorney would need to be involved with putting the bid package together. We will also need to be in communication with Green Acres.

COUNCILMAN GWON - RECREATION/LIBRARY/SCHOOLS

The First Aid Corps will be holding CPR courses at the library. Social services will be serving lunches to the seniors during Friday Flix. There is a new section where you can borrow toys for your dogs.

Soccer season has begun. Town Day is on September 9th. The pickleball courts will be painted within 2 weeks according to the vendor. There will be no pickleball tournament during Town Day.

COUNCILMAN YHU – DPW/SENIORS/FIRST AID

The Seniors are looking forward to Town Day. He will be shuttling them back and forth from the Senior Center and Stone Point Park throughout the day. Some will be attending Bergen County's Senior Picnic at Van Saun Park next Tuesday. They will be hosting a Lunch & Learn on Thursday, September 28th at noon at the fire house. A grant has been approved for a bus trip next month.

The First Aid Corps will be meeting soon to speak about the future of the corps and how they can best serve our residents.

The DPW is now searching for a new mechanic. They have held initial interviews now the DPW Committee needs to interview them. Read the August 2023 activity report.
