#### **COUNCIL COMMITTEE REPORTS**

#### COUNCILMAN BINAGHI – GRANTS/HISTORICAL

Town Day was postponed but the Historical Committee is still planning on having a presentation on the new date of October 28<sup>th</sup>.

#### COUNCILMAN GWON - RECREATION/LIBRARY/SCHOOLS

The Library Board reports that they are on budget. Circulation for the year is up quite a bit from last year. The River Vale library will be closing for about a month or 2 so they anticipate more people coming to Old Tappan. They had a leak in the Children's Room and have hired a structural engineer to find out what is causing it. They are working on the 2024 budget.

At the NVRHS board meeting potential renovations to the NVOT weight room were discussed as well as the budget. Roof repairs will be occurring over the next few years. The gate on Howard Drive was also discussed.

Discussion ensued on the NVOT gate near the football field and when it is opened and locked.

Soccer season has begun, the new head of that sport is doing well. The pickle ball courts opening has been delayed due to the weather. The vendor is hoping to continue work at the end of this week.

#### COUNCILMAN YHU – DPW/SENIORS/FIRST AID

The Seniors have a trip coming up on October 5<sup>th</sup>.

The DPW hired a new mechanic who was appointed earlier this evening.

The First Aid Corps has submitted their proposed LOSAP amendments. He will present this to the Borough's LOSAP Coordinator tomorrow. Their officers plan to attend the next meeting to speak about the future of the Corps.

#### COUNCILMAN CARNAZZA – POLICE/ADMINISTRATION/HEALTH

Read a letter from a resident complimenting Sergeant Reilly for a job well done. Read the August 2023 Police Activity Report.

#### COUNCILMAN BOYCE - GOLF/PLANNING BOARD/FIRE

Kemper has decided to place cards in each of the golf carts in regard to golf course etiquette. He met with the golf course manager and superintendent last week along with an architect to try and come up with a structural design for the \$80,000 we have budgeted for the cover over the terrace. During this meeting they also discussed a larger strategic plan to incorporate a virtual reality driving range in association with the upstairs dining area. This would help the golf course stay open in the winter and add another benefit for town residents. They are also thinking about all the different pieces of equipment they will need in the future. The Golf Committee chair, Tom Corcoran, has requested a refund of his membership due to an injury that has prevented him from playing this season. He will have Mr. Corcoran submit a letter to the Mayor and Council requesting the refund.

A price was received for the golf course fence that was presented to the Sheridan's today. Hopefully by our next meeting we will know what the Sheridan's have decided to do.

A discussion ensued on the various types of proposed fencing for the golf course.

Councilman Yhu inquired about alcohol on the golf course.

Mayor Kramer explained the history of the prohibition of alcohol at Borough parks and recreation facilities.

The Planning Board had 2 applications on their most recent agenda but both were adjourned to the November meeting.

The new truck for the Fire Department should be delivered in about a month. LOSAP has been discussed and the parameters will be forwarded to the LOSAP Coordinator. They will be collaborating with the First Aid Corps.

The Veterans had a good turn out at their last meeting. There are about 100 veterans in town and we are trying to reach out to all of them. At their next meeting they will be trying to figure out how to disseminate any information to all the veterans.

# COUNCILMAN GALLAGHER - FINANCE/CONSTRUCTION/ENVIRONMENTAL

He was approached by the Construction Official looking to tighten up our fence ordinance. He has invited him to attend the October Planning Board meeting to present his ideas.

#### **MAYOR'S COMMENTS**

Attended the audit exit interview where the Auditor gave the Borough a glowing report. There were only a few comments, no recommendations. The Auditor was very complimentary about the Borough's all around standing.

Councilman Boyce explained that there is relief in the ordinance for residents who are building new homes.

Councilman Binaghi is not in favor of this ordinance. Does not like telling residents what they can do on their property.
